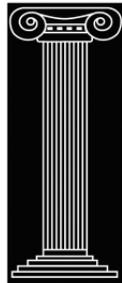

Five Ways to Maintain Control of Your Divorce

Ending your marriage can be emotionally and financially painful. By following the five rules listed below, it is possible to avoid hours (if not days) in court, control your legal expenses and be able to get through the pain of divorce and move on with your life.

- 1** Before you begin negotiating a property division you must thoroughly understand your assets and your debts. To divide up property without a thorough inventory could prove to be detrimental to you and your pocket book.

- 2** Gather as much information with respect to your assets and debts as possible. Gathering information through your attorney is generally called “discovery”. Although discovery is sometimes necessary, ask your lawyer what you can do to help gather this information yourself as it will save you money. Also, if you and your spouse are able to communicate it would be in both of your best interests to exchange this information with one another.

- 3** Before making a decision with respect to property division, maintenance or financial issues, seek the advice of a qualified tax specialist. Generally, your attorney is not a tax specialist although he or she will be able to retain the services of an appropriate professional. The tax impact of an agreement should be addressed before the agreement to avoid unfortunate surprises many months if not years after the divorce. Make sure that your lawyer is aware of your tax concerns so that the appropriate professional can be retained. Although it may increase your divorce expenses, it may save you thousands of dollars in the long run.

- 4** Be careful in allowing others to dictate the terms of your divorce. Remember, this is your divorce and no one can or should tell you what you should be feeling, saying and doing. Rely on your judgment and discuss your feelings with your attorney. The two of you will do a better job of dealing with these issues then leaving it up to friends, family members and others.

- 5** Last, if your spouse has filed a divorce be careful of trying to win him or her back by being generous. Often times, this generosity only leads to more debts and lost assets. There are ways to reunite that can be discussed with your lawyer; however, it is my experience that “giving up the farm” is not the way to gain the love and the return of your spouse.

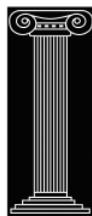
